

# OPINION: COMMUNITY SUPPORT NEEDED TO SOLVE OUR HOUSING PROBLEMS

"Whether you are a young professional looking for an apartment or part of a family of four seeking a new home, finding housing right now across our region is a struggle."

Our housing prices are higher than the Michigan average yet our wages are lower than the state average. What this means is that (1) our housing situation is interconnected with other local issues, from wages to childcare, and that (2) addressing our region's housing crisis requires a collaborative, cross-sector approach.

As a member of the Community Development Coalition of Northwest Michigan, Housing North is working alongside more than 30 nonprofit, governmental and business partners to tackle pressing societal issues like housing in addition to economic and environmental issues through a shared 10-year regional plan. Recently, the Coalition released the first year of progress grades as part of our Scorecard, a set of shared metrics that align our engagement efforts and transparently communicate progress toward community goals.

As the Scorecard shows, **our wages stand at only 69 percent of the Michigan average** and an astonishing **55 percent of local households are overburdened**, which is defined as those spending 45 percent of their income on housing and transportation. By 2030, the Community Development Coalition aims to increase the average regional wage by 3 percent and see a 5 percent reduction in overburdened households. It is clear that the need for both attainable housing and increased wages is now but there is plenty of work ahead to move the needle on these critical issues.



### **HOMES FOR OUR FUTURE**

Housing North has been doing what we can to tackle these issues, especially in relation to housing. Over the past year alone, we have: Joined the executive team of the Housing Michigan Coalition, a bipartisan effort, that recently worked to get five bills passed through the state House to allow us to bring more resources to our region for housing. The bills are now moving onto the Senate.

Expanded our Housing Ready Program to Leelanau County, which includes a coordinator and supporting housing efforts in the community. We are working to expand this program to the other four counties.

Launched a public awareness campaign for housing and introduced the Housing Ready Checklist and Communications Toolkit to more than 50 communities, receiving endorsements from 13 government units and more than 30 organizations. Launched a story maphighlighting regional projects in 10 counties that will help match developers with Housing Ready Communities and projects.

Since becoming a coalition contributor, we've seen how wonderful this community truly is and how much expertise and knowledge there is that, when organized well, can make an amazing impact on the people and places we love here. But community support is necessary to keep us all moving toward a housing ready region that's healthy, resilient and thriving.

#### HOW DO WE BECOME "HOUSING READY' IN NORTHWEST MICHIGAN?

"I know everyone is tired of talking about housing-they want solutions. I do too! We have come a long way, but the reality is IF we're going to move the housindg needle we need three things:

- **1. Become Housing Ready.** Northwest Michigan communities need to become poised for housing projects while removing barriers to development. Many of our communities are doing so and are on a Housing Ready path, but there's work to do.
- 2. Work Together. This is a community effort and is not any one organization, unit of government or individual's responsibility. We need to work creatively, collaboratively and strategically to address barriers to housing and bring solutions to our communities
- 3. Advocate. Our voices are being heard in Lansing, yet we still need to communicate, advocate and collaborate with state agencies and legislators to keep momentum going and make sure we have the necessary tools and resources.

We know there are creative solutions and many other communities to look towards as examples. But first we need to be ready for housing- to make sure our zoning allows for our local housing needs. We need to understand how we can all be part of the solution and work with the NIMBYs or Not In My Backyard folks to recognize the need for housing diversity and its importance in the community. We need to think about what it will look like if our schools close and northwest Michigan becomes a retirement community where the year-round workforce has no place to go.



#### WHAT DOES AFFORDABLE **HOUSING MEAN?**

It means people spend 30 percent or less of their income on housing.

This can be for someone making \$20,000 a year, or up to \$300,000/ annually. Ideally we want to make sure there is a variety of price points and housing diversity to meet all the needs in our community. We know from a recent Target Market Analysis the major need for housing is for those making \$40,000 a year or less. Without available homes at affordable price ranges, people must drive long distances and not live where they work. This is a huge concern in our region, where many of us spend up to 50 percent of our income on housing and transportation.

#### COMMUNITY LAND TRUSTS IMPORTANT FOR HOUSING AFFORDABILITY AND ATTAINABILITY

We've talked a lot of about new tools needed to expand the region's housing opportunities, whether it's in the form of zoning, financing or taxation. Among them is a Community Land Trust (CLT). It's a type of shared equity home ownership program which provides affordable home ownership opportunities to lower- to moderate-income households - and more recently even those making up to 120 percent of the Area Median Income (AMI). We're finding more of our year-round families priced out of the market, necessitating tools and models that provide home ownership opportunities and ensure long-term affordability.

Two new Community Land Trusts recently formed in



our region include the Frankfort Area Community Land Trust in Benzie County, and Peninsula Housing which is based in Leelanau County but has no geographical boundary restrictions. We know of others forming across the state and country. This tool is growing in momentum, and there is legislation proposed that would make taxes more affordable for it to be more widely used.

Another impactful tool used in collaboration with a Community Land Trust is known as Land Bank 2.0, where communities can utilize the Land Bank Authority, Brownfield Redevelopment Authority and Tax Increment Financing in partnership with a CLT and developer to provide attainable housing. One of the best resources for information on CLTs is the Grounded Solutions Network. We are also grateful to have a CLT in our region called the Northern Homes Community Development Corporation, and to work with Dwelling Place CLT which covers 15 counties in Michigan. These organizations and resources are helping unlock more housing solutions for families throughout Northern Michigan

# WHERE DO PEOPLE WHO ARE EXPERIENCING HOMELESSNESS GO IN WEXFORD AND MISSAUKEE COUNTIES?

Where do people who are experiencing homelessness go in Wexford and Missaukee Counties? For the past 29 years, New Hope Center has been able to provide emergency shelter for those that are experiencing homelessness. The Men's Shelter opened in 1992, a few years later, three homes were used for families experiencing homelessness, and in 2013, a Women's Shelter was opened for single women or single women with children. In May of 2020, New Hope Center broke ground on their new facility that will be able to combine all of the emergency shelters into one facility. One of our future goals is to be open 24/7 so the individuals that are working 3rd shift will be able to have a place to sleep without interruption. Another goal is to offer programs during the day that will benefit the individuals/families to help them improve their current situation.

New Hope Center kicked off their \$40,000 in 40 days "Cross the Finish Line" fundraiser campaign! We are getting excited to be able to open up our new facility by the end of the year! We have been very appreciative of the support that we have had from the community and surrounding communities! This last push will help cover the costs of the last few things that are needed to be able to provide our clients a warm and safe place to lay their head at night.

If you have not decided on where your year-end donation would like to go, please consider New Hope Center to help "Cross the Finish Line" and complete our new facility! This new facility will be able to provide more opportunities for our clients to be better served with all of the following done on site such as "Life Skills" training, Mentoring, Workplace Development, and Bible Classes. Imagine a family of four living out of their mini-van that will typically have to eat cold food, try and keep each other warm, and find a public restroom to use to get cleaned up. In the past, we typically have a waiting list for our family units, with the new facility we will be able to provide one extra family unit.

# HOW ARE WE AT A LOCAL LEVEL ADDRESSING THE HOUSING IN WEXFORD COUNTY?

The City of Cadillac believes housing is an important part of any community development program. Market studies have shown that the city has a housing shortage in all types of housing in both the home ownership and rental categories. To address this shortage the city has been very proactive in assisting housing developers to achieve their housing projects within the City of Cadillac. Two notable examples include the complete renovation of the 24-unit Maple Hill Apartments done by the Woda Cooper Companies in the southern part of the city, and the Cadillac Lofts, a 42-unit apartment project built by Michigan Community Capital located in the heart of downtown. The city is currently working with Michigan Community Capital to facilitate their building of Phase 2 of the Cadillac Lofts project, which would add another 40 to 50 apartment units within their mixed-use project. The city is also currently working with three local developers on the redevelopment of three additional downtown buildings, which are planned to add more than 40 additional apartment units. These projects are anticipated to be completed in the next couple of years, pending access to funding, supplies/materials, and availability of contractors to build the projects.

# HOW DOES THE CITY PROVIDE ASSISTANCE TO HOUSING DEVELOPERS?

The assistance the city provides to housing developers takes many forms, such as site design assistance, customized zoning through use of planned unit developments, streamlining the zoning process, brownfield assistance, grant assistance, coordination with state agencies such as the Michigan Economic Development Corporation (MEDC), and exploring other available tax abatement options. To further facilitate new downtown residential development, the city has, as a part of becoming a Certified Redevelopment Ready Community by the MEDC, adopted a zoning amendment which allows mixed-use projects "by right", which means a developer can administratively obtain certain necessary approvals in a timelier manner, versus also needing legislative consideration and approval.


# HOW DO YOU ENSURE THE QUALITY & SAFETY OF OUR HOUSING?

In addition to having the right supply of housing, the quality and safety of our housing is also a key objective for the city. In part due to the high percentage of rental housing in the city, the city operates a rental inspection program. All housing rentals are required to be registered with the city and all units are inspected every three-years to make sure they are maintained to the city's basic property maintenance standards. This program is effective in maintaining an ensuring housing quality, and the health and safety of the renting population in the city.

#### CITY OF CADILLAC AND OVERCOMING ZONING BARRIERS

Within the last few years, the city also had the opportunity to work with New Hope Shelter to write specialized zoning regulations to facilitate a new combined group/family shelter facility for the homeless. New Hope wanted to change from having separate housing facilities for men, women, and families to accommodating each of these groups within a centralized facility. **The new zoning regulations allowed New Hope to achieve their goal and create a facility with a 60-bed capacity.** Their new facility will likely start operation early in 2022.

The city is also in the process of doing a comprehensive updating of our zoning ordinance to ensure compatibility with the state's Redevelopment Ready Community Program. As part of this process we are very conscience of the need for affordable housing or housing for the "missing middle". One of the common zoning problems which act as a barrier to people entering the housing market is the requirement for a minimum housing size, especially if that minimum is set too high.



The city now, and in the new zoning ordinance, intends to not be specifying a minimum housing size, but will rely on the requirements of our building code to address this issue. This approach should make entering the new housing market easier for low to moderate income individuals. The city is also evaluating zoning techniques that can make housing more attainable such as allowing for accessory dwelling units (ADU's), and creating a district which allows both single-family detached and single-family attached dwelling units in the same zoning district.

As our residential areas grow the city is also focusing on increasing "walkability" in our neighborhoods. Residential housing in neighborhoods with high walk scores are in the highest demand. They create opportunity for a healthier way of living and reduce the dependency on the auto which reduces household expenses and thereby makes housing more affordable.

The city looks forward to collaborating with the Cadillac Chamber of Commerce, Housing North, Networks Northwest and other Cadillac agencies and industries on seeking and implementing housing solutions for our great city.

#### **CADILLAC LOFTS**



This four-story, new construction building is located at 207 South Mitchell Street, on the corner of South Mitchell Street and East Cass Street in beautiful downtown Cadillac! The building is constructed of highly durable steel and brick. The first floor contains retail/restaurant space with large glass storefronts and a shared patio space.





#### Goal of the Cadillac Lofts in Cadillac MI?

Our mission at Michigan Community Capital is to help build on the hard work of local organizations to catalyze community development. A big part of that is creating middle income housing to address the severe housing shortage statewide. Cadillac Lofts is a direct extension of that mission. Also, by adding a commercial component to this development, we are really engaging in a placemaking approach that can contribute to strengthening Cadillac's downtown.

#### What are the next steps in development for the second phase?

We are currently finalizing designs and financing. We expect to break ground this year.

# How can the Cadillac Chamber membership participate or support this upcoming year?

We're very grateful for the support the Cadillac Chamber has given us since we began the first phase of Cadillac Lofts a few years ago. The publicity we've received from the chamber helped us lease out the building very quickly, and we hope through continued promotion we will do the same in phase two.

In addition to working with non-profit organizations to provide critical needs and services, we have become the hub for connecting people to local resources to assist them with vital needs such as food, housing, and clothing. In 2020/2021 the Foundation provided countless volunteer hours and upwards of \$500,000 in financial assistance in support of a wide variety of needs and opportunities to improve our community.

We collaborated with Venture North, Small Business Resiliency Program to award \$27,500 in grants to 7 small businesses in Wexford County that continue to struggle due to COVID.

Supported a Facebook peer-to-peer group called Spark in the Dark. Spark in the Dark is an online platform to help people with emergency needs and share resources, and in the first 60 days, 103 requests were filled.

We awarded \$97,150 in scholarships to local graduates. The Cadillac Area Women's Giving Circle awarded \$20,781 to local non-profits that support programs and projects for women and girls.

We support our community non-profit leaders to help build a strong foundation for their organizations through Leadership Learning Lab, a nine-month program funded by Traverse City Rotary Charities, Frye Foundation, and our Community Foundation.

23,326 books were distributed from the Dolly Parton Imagination Library Book Program. Over 1900 children in the Wexford Missaukee ISD School District, ages 0-5, receive books monthly. Funding is from our Imagination Library Fund, which is completely funded by donations and grants.

The Foundation supported the New Hope Center's new building, Cadillac Leadership Class Shay Project, and the Wexford County Historical Society Window Project with grants of \$10,000 each. We continue to support our Wexford and Missaukee Veterans with emergency needs of; medical expenses, propane, firewood, utility bills, car repairs, rent, and housing from our Wexford Missaukee Counties Veteran Fund.

Cadillac Area Youth Advisory Committee awarded \$20,308 to programs and projects for youth in the Cadillac Area. We would not be able to do this without our generous donors; their gifts to the Cadillac Area Community Foundation enable us to address our community's most pressing needs and promising opportunities, both now and for generations to come.

We are looking forward to 2022, telling our story beyond the numbers of people we helped, the impacts achieved, and the resources we share; we want to share the stories of generosity and what philanthropy represents for our Community!

The USDA Forest Service annual National Engineer of the Year awards solicits regional applications from all 154 Forests across the nation, and from those finalists, the winners for the National Engineer Awards in Managerial. "Karen has excelled in applying her technical skills and focusing on our Forests relationships with our Road Commissions and Cooperators," Says Leslie Auriemmo, HMNF Forest Supervisor, "this has benefited the public we serve by increasing our conservation efforts across the forests."

When Karen started in 2016, the HMNF had roughly \$450,000 invested in 12 project agreements with six County Road Commission Partners\*. The program has now grown to 31 agreements valued at \$1.6 Million, with 11 County Road Commission Partners.

Recently Middleton was part of the Team awarded the 2020 Regional Forester Honor Award for Adaptive Reuse of the facilities at the Cadillac/Manistee Ranger District new administrative office in Wellston, at the historic Chittenden Nursery facility. She earned a 'Superior' performance rating in 2020 for excellent performance as a Civil Engineer/Forest Engineer on the HMNF. Also, earning the Certificate of Merit for the Forest Supervisor's Safety Award.

Middleton earned her Bachelor of Science in Civil Engineering from the University of Dayton, earned her PE in Michigan and Alaska, and has completed numerous engineering related trainings in Leadership, Collaboration, Timber Contracting, Aquatic Organisms Passage, Safety, NEPA, and Artic Engineering.

During her engineering career she has worked in both the private and public sector focused on transportation engineering. She has been with the USDA Forest Service, Huron-Manistee National Forests since 2016.

\*The Huron-Manistee National Forests greatly value the cooperative efforts of our County Road Commission partners working continuously to annually maintain over 400 miles of roads in the most cost-effective way possible. This cooperation enables the HMNF to maximize funding across roads and facilities along the 2,000 plus total miles of roads and 140 plus facilities across the forests.

Lying between the shores of Lake Michigan and Lake Huron in the northern half of the Lower Peninsula of Michigan, is the nearly one-million-acre Huron-Manistee National Forests. The Forests offer yeararound motorized and non-motorized recreation opportunities. Most popular are the trails and campgrounds along four nationally designated Wild and Scenic Rivers such as the Pine, Manistee, Au Sable and Pere Marquette. The Forests management team of botanists, biologists, archeologists, fire, timber, and silvicultural specialists manage for health, harvest, prescribed fire and endangered/ sensitive species habitat.
